

## Reported Fatal Incidents in 2015

### A large portfolio of companies across several high-risk industries

CDC's capital is invested in 1,331 companies in 74 countries. Of the companies that reported employment data for 2014 (the most recent data available), we know that they employ more than 1,277,000 people. Given the large number of employees, the large number of high-risk sectors in the portfolio and the relatively higher levels of risk that characterise emerging markets, it is not unexpected that a number of CDC's fund managers and investees have reported fatal accidents and other serious incidents in their portfolios.

### What CDC requires from its fund managers and investees to address serious incidents and fatalities

CDC requires its fund managers / investees to report without delay any instance involving portfolio companies / operations which results in loss of life, material effect on the environment, or material breach of law and how such an instance was dealt with by the fund manager / investee. CDC takes each notification very seriously and follows up with the relevant fund manager / investee to ensure that complete reports are written (including police and other reports where applicable), that any underlying systemic reasons are identified and that corrective action plans are implemented to prevent recurrences.

### Working with investments to reduce fatalities and reach improvements over time

When investing in emerging markets, CDC believes it is important to add value by reaching countries, regions and sectors where it can expand access to finance, make it more affordable and also bring other benefits to these markets. In such environments it is difficult to avoid the risk of fatalities and also important not to shy away from such cases. Rather, it is imperative to identify commercially viable businesses, with great potential to have significant development impact. It is also essential that the management shows a genuine willingness to improve its performance across ESG matters over time to ensure commercially, environmentally and socially sustainable development.\*

*\* In addition to the instances reported here, there have been a number of fatalities beyond our portfolio companies' control, caused, for example, by an individual's use of a utility in his or her own home. Examples include situations when homemade wiring was connected to power lines or unqualified personnel were used to make connections. The company and fund manager track every reported event. This information is then used to inform safety-related education and communication programmes, particularly in schools and through radio messages, to help people to understand the dangers of electricity – which is poorly understood in some countries.*

The truck fell into a roadside ditch, was overturned and was left resting against roadside trees. Four of the victims died on spot due to the weight of the materials and twelve others were injured. The lorry driver fled the scene after being threatened by a mob. |

According to the police, the lorry was driving at high speed when five female pedestrians attempted to cross the road. When the driver manoeuvred towards the left side to avoid the pedestrians, the driver lost control and crashed into an aggregate stockpile on the side of the road, resulting in the fatality. National Cement believes that the fatality occurred as a result of the driver's excess speed and thus immediately called an emergency meeting of all National Cement drivers at the site to discuss the incident and explain how critical it is to prevent such accidents from happening. Both National Cement's management and Schulze took the incident very seriously. The company subsequently installed a GPS system on all vehicles to minimise the risk of similar incidents happening again. The GPS system monitors the location and speed of the vehicles. The company has also provided ongoing training and introduced disciplinary actions to encourage drivers to drive within recommended speed limits.   |

An employee was driving a vehicle at night on unauthorised personal business. A passenger in the vehicle was killed in the incident, while the employee was injured and taken to Mafinga District Hospital and was released after treatment. An initial assessment suggested that the accident was due to excess speed, a failure to identify hazards, a failure to react to / correct a skid, poor road conditions (slippery surface / felled trees on the roadside), driving at night and human error. The employee stated that prior to the accident, the LH front tyre on the vehicle burst, but there was no evidence pointing to this. The employee appeared in court on 4 November 2015, where he pleaded guilty to causing death by carelessness, and careless or inconsiderate use of a motor vehicle. No further action was to be taken and he was sentenced to a fine of TShs 100,000 (approx US\$45), which he paid. Silverlands Tanzania claimed on insurance and, on 19 January 2016, the insurance company paid out for the vehicle. Remedial actions such as defensive driver training, rigorous eye tests for all drivers and an updated safe-travel policy have been implemented by the company. |

The construction contractors have since effected several corrective actions to address safety lapses on site, including increased frequency of site risk assessments and safety audits to identify site hazards, inclusion of guardrails and handrails in formwork structures at building heights, increased monitoring and evaluation of guardrails and handrails, increased enforcement of compliance with personal protective equipment use and implementation of stricter disciplinary measures for non-compliance with site safety measures. |

The unarmed security guard on duty alerted MOPOL, who dispatched an inspector who engaged the burglar and was overpowered, sustaining a major head injury which left him unconscious and the burglar in possession of his firearm. The company security guard was able to alert the police and escaped uninjured. However, the burglar evaded arrest. The MOPOL inspector died from his injuries on 8 February 2015. |
